## CIDA Student Achievement Data

Interior Designers Institute's Interior Design Program leading to the Bachelor of Arts in Interior Design Degree is accredited by the **Council for Interior Design Accreditation** (CIDA).

The Bachelor of Arts Degree in Interior Design Program is a 4-year degree scheduled on a term/quarter system. The student has the option of completing this Program in 30 to 54 months.

The following data was collected using institutional records and an alumni survey that was administered after the class of 2023 graduated.

### Student Achievement Data

#### Graduation Rates

- 100% of the 2023 graduates completed the **Bachelor of Arts Degree in Interior Design** Program graduated within 100% of normal time (4 years). #### Job Placement

- 63% of the on-time completers, or 5 students who graduated in 2023 from the **Interior Design Bachelor of Arts Degree** were employed within six months of graduation in a field related to interior design as reported in the BPPE Annual Report on 12/01/2024 (<https://www.bppe.ca.gov/>). The 2023 BPPE Annual Report for the Bachelor of Arts Degree program can be found on the pages following. 9% enrolled in the Master of Interior Architecture Degree at Interior Designers Institute.

#### Acceptance into Graduate Programs

- 100% of students who graduated in 2023 and applied for the IDI Master of Interior Architecture Degree Program were accepted.
- Percent of the Interior Design class of 2023 who applied to other graduate school: unknown

#### Retention/Attrition

- 92% of the Bachelor of Arts Degree in Interior Design students enrolled in the Fall 2023 returned the next Fall, for 8% attrition.
